## **RCPCH COVID-19 guidance**

RCPCH is providing a range of <u>COVID-19 information and guidance</u> that is updated regularly. This includes

# **Work of the RCPCH Child Protection Standing Committee**

Below is a summary of some of the pieces of work that are currently being discussed and undertaken by the Committee:

- A range of work around Looked after Children is being carried in liaison with Coram BAAF and other partners.
- A review is being carried out of the Safeguarding SPIN module.
- The RCPCH Peer review in Safeguarding guidance is being updated.
- There is work taking place with FFLM and the RCN around CSA services.
- Ongoing work on haematology pathway with regards to investigations in possible inflicted injury.
- Implementing the expert witness in family court action plan.
- There is ongoing work on a number of publications, see section below for more details.
- A working group will be reviewing the RCPCH position statement on mandatory reporting.
